

**SHICKSHINNY BOROUGH
COUNCIL MEETING MINUTES
April 13, 2021**

The General Meeting of the Borough of Shickshinny Council was held on Tuesday, March 13, 2021 in the council room of the Shickshinny Municipal Building. President Rosalie Whitebread called the meeting to order at 6:00 pm.

Per roll call, the following members of council were present: Candy Kruczek, Kevin Kruczek, Rosalie Whitebread and Jim Wido. Joe Buchalski was absent. Attorney Burke and Lori Ragazzo were also present.

Solicitor's Report- *Attorney Burke spoke with Mr. Grabowski regarding the Rinehard Property, Mr. Grabowski stated that the survey/subdivision would be done soon, there were changes to the boundary lines by agreement of the parties. Mr. Rinehard was not present for this report, but was explained again when he arrived.*

Attorney Burke also spoke with Mr. Grabowski about the Hook property, Frank stated that the survey for that is in the process.

Attorney Burke informed Council that he filed the paperwork for the Right to know appeal.

President Whitbread asked Attorney burke where he was with getting the Title for the property at 56-57 West Union Street.
